RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF STELLARTON, THAT THE FOLLOWING AMENDMENT TO THE TOWN OF STELLARTON MINIMUM PENALTY BY-LAW IS HEREBY ENACTED UNDER THE AUTHORITY OF SECTION 305 OF CHAPTER 293 OF THE RSNS, 1989 AND THE TOWN CLERK IS HEREBY INSTRUCTED TO FORWARD TWO DULY CERTIFIED COPIES OF SAME TO THE MINISTER OF MUNICIPAL AFFAIRS, REQUESTING APPROVAL HEREOF.

SECTION 2. SHALL READ "THAT A PENALTY FOR THE VIOLATION OF ANY BY-LAW OF THE TOWN OF STELLARTON, NOT HEREINBEFORE PROVIDED FOR, SHALL BE A SUM NOT EXCEEDING ONE THOUSAND (\$1,000.00) DOLLARS AND NOT LESS THAN ONE HUNDRED (\$100.00) DOLLARS, AND IN DEFAULT OF PAYMENT OF SUCH PENALTY, THE OFFENDER MAY BE IMPRISONED FOR A PERIOD NOT EXCEEDING THIRTY (30) DAYS."

UNANIMOUSLY RESOLVED by the Town Council of the Town of Stellarton, that the following By-Law be and the same is hereby enacted and that the Clerk be and is hereby instructed to forward same to the Minister of Municipal Affairs with a request for his approval hereof.

By-Law of Penalties for Breach of Town By-Laws

1. All existing penalties provided for the violation of any By-Law of the Town of Stellarton made under the authority of the Towns Act is hereby repealed, unless the existing penalty is greater than that hereinafter set out.
2. That a penalty for the violation of any By-Law of the Town of Stellarton, not hereinbefore provided for, shall be a sum not exceeding One Thousand (\$1,000.00) Dollars and not less than Fifty (\$50.00) Dollars, and in default of payment of such penalty, the offender may be imprisoned for a period not exceeding Thirty (30) Days.
3. It is hereby provided that upon conviction for violation of any By-Law requiring a person to obtain a license, the Justice or Magistrate may in addition to any penalty, order the defendant to pay the fee for such license.
