**APPROVAL OF PREVIOUS MINUTES**

The Minutes of February 25, 2019 were approved on motion by Coun. S. Campbell seconded by Mayor D. MacGillivray. **Motion Carried.**

**BUSINESS ARISING FROM THE MINUTES**

**CORRESPONDENCE**

- a. Pride Pictou County Re: Flag Raising July 10, 2019 – for Council's consideration and information for Pride Pictou County Flag Raising in New Glasgow on July 10.
- b. Pictou Landing Band Office Re: 28<sup>th</sup> Annual PowWow Celebrations – Council's information; event to be held June 1 at the Wayne Michael Memorial Gymnasium in Pictou Landing.
- c. Pictou County Historical Society Re: request for donation. Town Clerk S. Higdon reported that this is included in the Annual Grants for \$100. Coun. G. Pentz motioned to approve \$100 donation for the Pictou County Historical Society, seconded by Mayor D. MacGillivray. **Motion Carried.**

**NEW BUSINESS**

- a. Fire Department Expired bunker gear – Town Clerk S. Higdon reported that Coun. Lawand had looked at donating the expired bunker gear from the Stellarton Fire Department to a city in Lebanon for training purposes; checked with Town Solicitor for legality issues. Coun. G. Pentz made motion to approve donating expired bunker gear to the city of Nabatieh, Lebanon, seconded by Mayor D. MacGillivray. **Motion Carried.**
- b. Bingo Equipment Lease – Town Clerk S. Higdon re Council's consideration; Soccer Sports Complex is looking at taking over the Bingo from the Stellarton Rink; asking for the Town's Bingo Equipment; provincial governance; Stellarton needs to release to Arrow Games to verify that the equipment is OK to use and that they can take ownership; not allowed to sell; leftover cards have to be destroyed. This was previously discussed where Council agreed to lease equipment for one year to the Sports Complex, provided that it is OK based on Arrow's evaluation. Coun. G. Pentz made motion to lease Bingo equipment to the Sports Complex for one year, seconded by Coun. S. Campbell. **Motion Carried.**  
Town Clerk S. Higdon added that they are also requesting the use of tables and chairs from the Rink for Bingo. Coun. G. Pentz motioned to loan table and chairs
