




Town Hall Updates

Low Income Property Tax Exemption

If your household income is \$29,693 or less, you are eligible for a \$300 rebate on your final property tax bill. This exemption will be applied to your tax account during the final property tax billing in September 2025.

You must provide a copy of your 2024 Notice of Assessment received from the Canada Revenue Agency as proof of income.

Fire Department Burn Restrictions

As we move into our warmer and dryer seasons, residents are reminded that there may be burning restrictions in place.

During wildfire risk season (March 15 to October 15), no domestic brush burning or campfires are allowed between 8am and 2pm, except industrial permits.
