Terms & Conditions (Stellarton Equipment Loan Program):

1. **General:** The renter shall be responsible for their participants and guests and must enforce the terms and conditions to all. The rental period shall last a maximum of seven (7) days, unless otherwise approved by the Town of Stellarton. The renter shall be responsible for damages or loss of the equipment during the rental period and shall pay for necessary repairs/replacement.
2. **Clean-up:** The renter is responsible for the cleaning of borrowed equipment before it is returned to the Town of Stellarton.
3. **Waiver:** The renter shall defend, indemnify and save harmless the Town of Stellarton, its elected officials, officers, employees and agents from and against any and all claims of any nature, actions, causes of action, losses, expenses, fines, costs (including legal costs), interest or damages of every nature and kind whatsoever, including but not limited to bodily injury, sickness, disease or death or to damage to or destruction of tangible property including loss of revenue or incurred expense resulting from disruption of service, arising out of or allegedly attributable to the negligence, acts, errors, omissions, misfeasance, nonfeasance, fraud or willful misconduct of the renter, its directors, officers, employees, volunteers, agents, contractors and subcontractors, or any of them, in connection with or in any way related to the delivery or performance of this rental agreement contract. This indemnity shall be in addition to and not in lieu of any insurance to be provided by the renter in accordance with this contract and shall survive this contract.
